Paul O'Brien recommended that the Corporation CEO and CFO document the fee deviation in the staff report and provide rationale for deviation therein. Board agreed with this recommendation.

Gary Weiss moved to recommend the 2014 Budget be approved by Board. Bruce Ungar seconded the motion. The motion passed unanimously.

## B. FY2015 Proposed Budget

Joseph Foarile, NCLEAC Chief Financial Officer, said he built the 2015 budget conservatively with marginal increases over FY2014.
